TEN YEAR LIMITED WARRANTY

Limited Warranty:

West Coast Netting, Inc warrants only to original purchaser _____ that the netting described on invoice _____ manufactured by West Coast Netting is free from defect in material and workmanship from this date _____ to _____ .

Warranty Adjustments:

West Coast Netting, Inc agrees to repair or replace at no charge, but not to remove or install, the above described netting if, within 120 months from purchase date stated above and upon test and examination by West Coast Netting, a defect in material or workmanship is discovered.

Purchaser shall notify West Coast Netting of any defect applicable to this warranty no later than 7 days after the defect is discovered.

No netting will be accepted for repair or replacement without prior written authorization of West Coast Netting. After authorization and instructions from West Coast Netting, the netting will be returned to West Coast Netting. If the netting is found to be defective due to workmanship or material, West Coast Netting will pay shipping charges for material to be returned to West Coast Netting and for replacement or repair to be returned to purchaser. If netting is NOT defective due to workmanship or material, purchaser will pay all shipping charges.

Exclusions from Warranty and Liability Limits:

This warranty is limited solely as set forth herein and applies only for the time periods designated.

West Coast Netting shall not be liable for any loss, damage, special or consequential damage of any kind, whether based upon warranty, contract, negligence, or strict liability arising in connection with the sale, use or repair of the above described netting.

The maximum liability of West Coast Netting in connection with the warranty shall not in any case exceed the purchase price for the netting only, which is claimed to be defective or unsuitable.

This warranty does not extend to or apply to any netting that has been subjected to misuse, neglect, vandalism, accident or improper installation. Improper installation is any deviation installation or selection of materials or procedures specified by West Coast Netting. Proper installation methods shall include vertical and horizontal cable/rope support. Diagonal or X-bracing are not recommended methods of installation and will not be covered by this warranty.

This warranty does not extend to or apply to any netting that has been subjected to and thus damaged by a wind force greater than 60 miles per hour within 30 days of the reported defect, as recorded by the nearest National Weather Service Station to the facility.

This warranty does not extend to or apply to any netting subjected to and thus damaged by snow and/or ice loading conditions.

This warranty does not extend to or apply to any netting that has been repaired or altered at any location other than West Coast Netting's manufacturing facility or by people not specifically approved by West Coast Netting.

The seller may have made oral statements about the netting described in this limited warranty. Such statements do not constitute warranties, shall not be relied upon by the buyer and not part of either the limited warranty or the sales agreement between the parties. The entire limited warranty is embodied in this writing. This writing is the final expression of the parties' agreement and is a complete and exclusive statement of the terms of the agreement.

There are no warranties that extend beyond the description of the face hereof.

In the event payment is not made and this account is referred for collection, buyer will pay cost of collection equal to a minimum amount to 20% of the principal amount. Also, buyer understands interest on any unpaid balance over 30 days old will be charged at the rate of 1 ½% per month. If suit or action by an attorney is instituted, buyer promises to pay attorney fees in said suit or action. It is specifically understood that West Coast Netting, Inc corporate headquarters is located in Kingman, Mohave County, Arizona. As a result, it is understood that in the event of suit or action, same shall take place in Kingman, Mohave County, AZ. Buyer understands that they are waiving their right to litigate outside of Mohave County, AZ.

This warranty gives you specific legal rights. You may have additional rights that vary from state to state.
